All My Papers Releases X9 QUALIFIER for Image Cash Letters

The X9 QUALIFIER application enables testing, validation, and auto correcting of TIFF check image files contained in X9.37 files and is a capable tool for testing interoperability and maintaining data integrity.

The **X9 QUALIFIER** is designed for anyone working with or implementing a system that will process X9.37 files. The application will reduce implementation costs, time and ongoing maintenance efforts, and can be used in many financial institution departments such as:

- Operations
 - Ensures TIFF images received in X9.37 files are interoperable and can be processed in your environment
 - Ensures TIFF images in outgoing X9.37 files are interoperable and will not be returned for TIFF format issues
 - Certify remote deposit customers X9.37 files for interoperable image format
 - Create detailed report of non-conforming TIFF check images
 - Correct check TIFF images for conformance to X9.100-181 "Specifications for TIFF Image Format for Image Exchange" standard

Development

- Ensures check image capture systems produce X9.37 files with interoperable TIFF images
- Analyze problems with non-conforming TIFF images
- Build workflow solution for processing X9.37 files that contain non-conforming TIFF images
- X9 QUALIFIER functionality can be built into solutions using All My Papers AX9LIB SDK

Testing

- Certify that X9.37 files produced by capture and clearing systems contain interoperable TIFF images
- Certify that check scanner hardware produces interoperable TIFF images
- Troubleshoot problematic X9.37 files

Built on the .NET Framework, the **X9 QUALIFIER** tests, certifies, reports and automatically corrects using the Microsoft Windows operating system.

"The **X9 QUALIFIER** is a software application whose value increases with the exponential growth of Image Cash Letter exchange" said Larry Krummel, President of All My Papers. "When a financial institution finds a bad check image TIFF file in a 25,000 item cash letter, it needs to be quickly deleted or corrected and the new file sent off to meet the deadline. The **X9 QUALIFIER** gives these institutions a simple, fast and cost effective tool to do that and many other functions."
